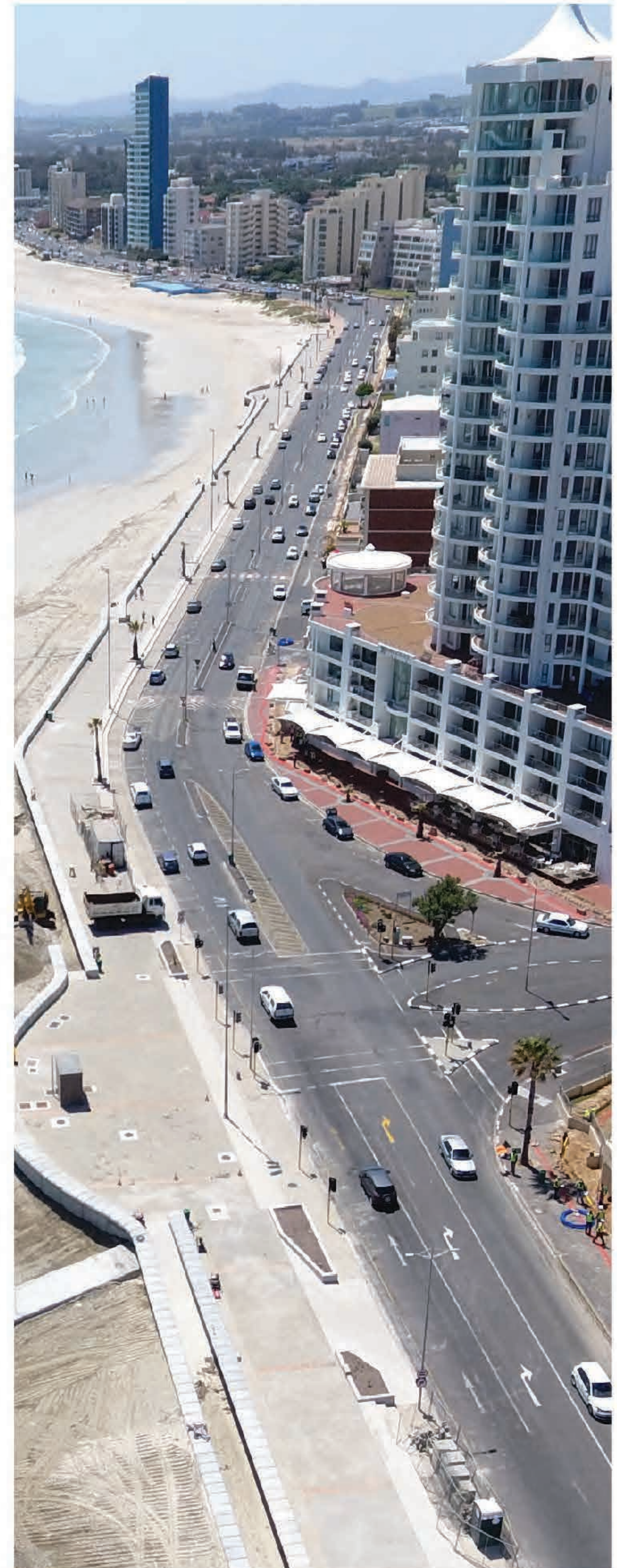

Pipeline & Service



We have undertaken many projects involving the installation of stormwater, sewer and water reticulation pipelines and structures, channels, dams and detention and attenuation ponds.

Building



We work closely with our clients to build vibrant and functional commercial buildings that offer attractive spaces for living and working, and industrial buildings offering the quality required for optimum function.

Earthworks



Civils 2000 provide civil engineering earthworks and land development services and undertake large-scale infrastructure, commercial and residential developments.

These projects also typically include road construction and asphalt or paved surfacing, retaining walls and pedestrian paving.

Roads & Surfacing



We have a large fleet of road construction plant and the experience needed to manage and deliver any road project. Our surfacing division, Roadsmart, provides services to private clients and developers, and municipal, provincial and national road authorities. This includes asphaltting, recycled asphalt, BSM, slurry seals, Cape seals, and chip and spray seals.

Civils2000 regularly collaborates with the renewable energy sector and examples of this includes the BOP works on Sere Wind Farm for Siemens & Eskom (access roads, crane hardstand areas and 46 concrete foundation bases, Darling Wind Farm bases, Lesedi PV civil works, Letsatsi PV civil works Burgan LPG terminal in Cape Town harbour and the Avedia Energy LPG terminal in Saldanha.)
